# THE RADIOLOGIST'S VIEW



## You Can Stop Feeling Guilty Now

Was there ever a time when you failed to do something and then found out that you didn't have to do it anymore anyway? Maybe like being told to use margarine instead of butter but you used butter anyway, later to be told

that margarine is bad for you. What a relief! No need to feel guilty anymore. Well, this scenario is now playing out with patient gonadal and fetal shielding when using x-ray. The American Association of Physicists in Medicine (AAPM) has recently released a position statement that affects this issue.

The position, referred to as "AAPM Position Statement on the Use of Patient Gonadal and Fetal Shielding", was issued on April 2, 2019 with a sunset date of December 31, 2024.<sup>1</sup> The change was based on the latest findings regarding technology, radiologic practice and patient safety. Essentially, the statement takes into account the benefit versus risk factors in noting that some anatomy is not able to be assessed since it is blocked by the shielding. In part, the statement is as follows: "Patient gonadal and fetal shielding during X-ray based diagnostic imaging should be discontinued as routine practice. Patient shielding may jeopardize the benefits of undergoing radiological imaging" The rationale for the policy is "Gonadal and fetal shielding in X-ray has for decades been considered consistent with the ALARA principle and therefore good practice. Given advances in technology and current evidence of radiation exposure risks, the AAPM has reconsidered the effectiveness of gonadal and fetal shielding."

# THE RADIOLOGIST'S VIEW (Cont From Pg 6)

According to the International Commission on the Radiological Protection, a source cited in the statement, “no human studies provide direct evidence of a radiation associated excess of heritable disease” when using diagnostic imaging levels of radiation. The policy statement also notes that patient shielding is ineffective in reducing internal scatter. Other concerns include the fact that shielding can obscure anatomy which may lead to repeat exams and limited information. Also, shielding can may affect automatic exposure control and the quality of the image and result in increased exposure.

The statement makes the assumption that the equipment and related technology are up to date, that there is a necessity for the x-ray and that the other standards that reduce radiation exposure are utilized. In other words, the principle of “As Low as Reasonably Achievable” (ALARA) are adhered to. The most effective way to reduce radiation is to clearly have a need for the information that the x-ray may yield. Some patients worry about x-ray exposure and may feel more comfortable with the use of shielding. For those, the statement suggests that shielding be used to reduce patient anxiety which may minimize motion and improve image quality. Interestingly, the American Society of Radiologic Technologists (ASRT) has elected not to recommend the position statement of the AAPM, noting that more research is needed.<sup>2</sup>

There are, however, several other factors that should continue to make you feel guilty if they are not understood and utilized when performing an X-ray exam. The first and foremost is appropriate use. That is, there must be a clear benefit to the use of ionizing radiation that outweighs the risk. A clinical question must be developed that can only be answered by a radiologic exam. X-ray should not be performed for any other purpose, certainly not for monetary gain or on the insistence of a third party. Other factors that may produce guilt if not followed are related to image quality and include collimation, patient positioning, performing adequate views and proper exposure factors.

The responsibility and privilege of using diagnostic imaging requires constant monitoring of the latest available technology, research and recommendations. If you stay current and incorporate changes there will be less, or perhaps more, to feel guilty about.



# THE NATIONAL BY FCA 2019

## SCHEDULE OF REQUIRED HOURS

FL DC License Renewal Requirements: If this is NOT your first biennium renewal, you are required to accumulate 40 hours before March 31, 2020 in the following categories:

27 Clinical CE, 6 DOC, 2 MED, 2 ETH, 2 FLR, 1 RM.

You may obtain more than the minimum number of hours in required sessions as long as your total number of hours for the biennium is at least 40. Each FCA CE event offers up to 20 hours in DC license renewal courses.

The Board of Chiropractic Medicine added a 4-hour requirement ONLY for DC's certified in Acupuncture starting with biennium 2012-2014. These requirements must be in 2 hours of Acupuncture Technique & 2 hours of Acupuncture Risk Management (THIS DOES NOT FULFILL the general RM requirement for FL DC's).
