What the Clinician Should Know About Diagnostic Imaging

Working through the various diagnostic imaging courses in chiropractic college is an essential component of the right of passage to the Doctor of Chiropractic degree. This generally includes the study of physics and clinical courses in bone, joint, trauma, chest and gastrointestinal radiology. There is a focus on patient positioning and radiation protection in the later part of the curriculum. The amount of information that is presented in each course can be overwhelming but is often required to meet accreditation standards. Over time a paradigm shift seems to be developing as imaging and computer technology demands a different approach to training doctors. The need to distinguish a giant cell tumor from an aneurysmal bone cyst or a chest tumor from an extrapleural lesion, is not necessary to become a successful clinician. Instead, understanding appropriate use of diagnostic imaging modalities is becoming increasingly vital in modern day practice. So, what should the practicing

physician know.

1. Imaging modalities – If the evaluation of a patient leads to a clinical question that can be answered by diagnostic imaging, it is important to understand the various imaging modalities that are available to answer that question. Although x-ray is often thought of as the portal of entry imaging modality, it often fails to provide sufficient information. Proceeding to the next modality or choosing the initial one requires a thorough understanding of the physics, capabilities and limitations of that modality.
2. X-ray community standards – If a physician performs in-office x-rays, there is an obligation to adhere to community standards. There are well established views and series as well as evidence-based indications and contraindications for the use of ionizing radiation.
3. Ordering advanced imaging - If one modality fails to answer the clinical question, additional imaging may be necessary. The decision as to the next appropriate step requires an

understanding of the advanced modalities and how to order them. Ordering advanced imaging is usually done by body area, for example, an MRI of the lumbar spine. The sequences that are performed can be modified to fit the clinical diagnosis, so it is important that the clinician supply the significant and relevant clinical information. The radiologist can then modify the protocol if needed. The indications for contrast imaging need to be understood. In cases of trauma, the mechanism of injury is an essential bit of information that is required on a requisition. New standards and procedures for ordering advanced imaging has begun and, like many regulations, they are starting with Medicare. Appropriate use criteria rules have been developed and will soon begin on the Federal level, likely filtering down to commercial carriers. In general, ordering physicians will be required to get approval before additional studies will be reimbursed. The decision will be evidence based and not determined by policy limits or made arbitrarily.

4. How to review images – This requires familiarity with a DICOM viewer, a topic that was discussed in a previous article.

5. Speaking radiology – It is essential that the practicing physician be able to understand (in a sense, translate) the imaging report into an action. Some reports contain unfamiliar terminology, unusual differentials as well as angular and linear measurements. If needed, referring physician should feel comfortable with asking the radiologist to clarify

the terminology or descriptions. Further imaging recommendations may be made in the report, but it is ultimately the referrers decision as to necessary follow-up. There is a movement in the radiology community to make reports patient friendly due to the access that patients have to their medical information.

6. What to do with the information – Ultimately the physician needs to decide if the imaging modality ordered answered the clinical question. The results of the studies need to be incorporated into the patient's file. That does not only mean that a copy of the report is included, but that the results have been acknowledged and that there has been confirmation of the diagnosis or indication for additional testing. A notation demonstrating some type of action should be reflected in the file. This may manifest as a change in diagnosis, change in treatment, prognosis or referral.

When it comes to the use of diagnostic imaging, the practicing physician need not be concerned with differentiating Paget's disease from fibrous dysplasia but rather how to use diagnostic imaging appropriately, efficiently and safely. The radiologist is there to guide you through the process. The team approach is the one that will benefit the patient the most, so focus and improve on that which you do best, patient care.

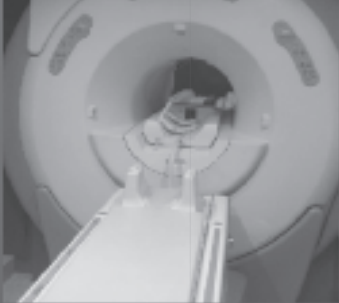

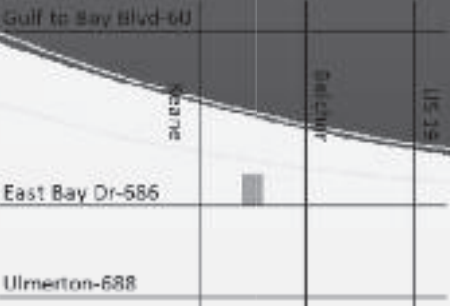
